FCOA Annual Business Meeting

The Florida Council on Aging touches at least 3.5 million elders in Florida

- 1) As of August 1, 2018, FCOA held a cash balance in its checking account of \$110,715.72 and in its savings account of \$12,012.73 for total cash on hand of \$122,728.45.
- 2) A full audit review of fiscal year 2017 was conducted by James Moore & Company, independent certified public accountants. The independent auditors' report indicated that the financial reports presented fairly, in all material aspects, the financial position of FCOA as of December 31, 2017. 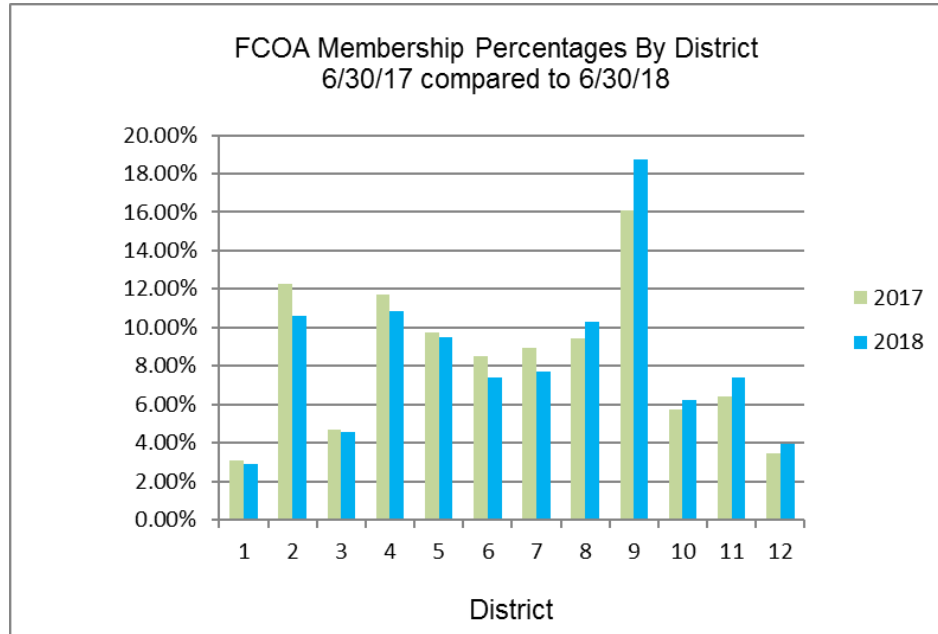

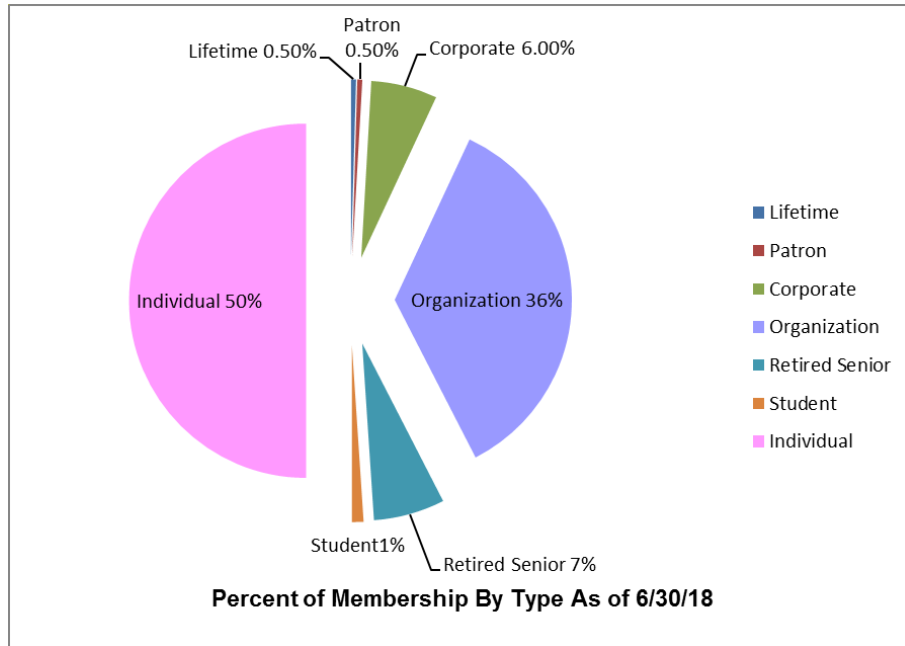
